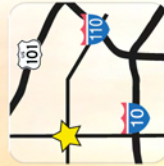

IMMEDIATE FAMILY OF MILITARY

Spouses, parents, and children, of U.S. Military.

USCIS has a program (PIP) which permits parents, spouse, or children of active duty and veterans of any branch of the U.S. Armed Forces, including the reserve to attain permanent residency in the U.S. Call us to see if you qualify.

STATESIDE PROVISIONAL WAIVERS

If you are married to a U.S citizen and entered the U.S. without legal admission

U.S. citizen spouses may now file their unlawful presence waiver in the U.S. Attorney Silvia Aguirre will evaluate your case to see if you qualify and have the necessary hardship to win your permanent residency.



DEFERRED ACTION FOR THE YOUTH

A receipt of DACA is able to get a work authorization, social security number and drivers license

If you came to the U.S before 16 years old, were under 31 years old on 6/15/2012, have high school diploma or currently are enroll in school, and have a good character, then you can apply for a work authorization.

There are still many that have not taken advantage of this program. Encourage family and friends to not miss out. If you came in prior to 16 years old, and did not go to school you can take E.S.L. classes now and still qualify. If you do not have the money, there are loans available for the the filing fee with payments as low as \$40.00/mo.

Travel authorizations with DACA or TPS

DACA or TPS recipients can apply for a travel permit. Upon re-enty, they will be inspected into the U.S. permitting them to attain permanent residency in the U.S through a U.S. citizen spouse.

U-VISA FOR VICTIMS OF CRIMES

If you have ever been a victim of an assault, robbery, domestic violence and have reported it to the police you may qualify for a 4 year work authorization and permanent residency after 3 years. Set up a free consultation to see if you qualify.

CITIZENSHIP

See if you qualify for U.S Citizenship fee waiver, or to take the exam in spanish

If you are of low income the government will waive the \$680. fee. If you are over 50 and 20 years as a resident or over 55 and 15 years as a resident then you will be able to take the exam in spanish. Do not wait any longer.

DRIVER LICENSE FOR ALL CA RESIDENTS

In January 2015, California will grant driver license to any resident of the state, regardless of immigration status in the U.S.

If you or a family member has any outstanding tickets or warrants, make sure they have been taken care of. We can recall warrants and help avoid detention.
